CONSIDERATION OF RESOLUTION TO DISPOSE OF OBSOLETE EQUIPMENT: Principal Stout advised the Board that the District is not utilizing the oldest bus in the fleet, a 2004 IC BUS; the District has four route busses, two spares, and the panther bus; its intended use was transporting students to the school farm; the bus has no trade in value, but can possibly be sold for \$5,000. John Russ Hamilton moved to approve the resolution to dispose of obsolete property for the 2004 IC Bus, with proceeds being credited to the Elementary Bus Depreciation Fund. William Fabel seconded the motion, and the motion carried.

CONSIDERATION OF TRAFFIC EDUCATION INSTRUCTOR CONTRACT: Superintendent Wetherbee advised the Board that the District has been in a bind for a traffic education instructor; he explained the contract has a provision for the District to pay for Mr. Johnson to receive his traffic education certification and require him to teach the course for the next two summers; John Russ Hamilton moved to approve the traffic

Traffic Ed Contract education instructor contract, and Klint Todd seconded the motion. Discussion included, but was not limited to, the following: MTSBA was consulted for the contract language; the SFT was informed of the issue; under the CBA, the credits can't be used for Mr. Johnson to change lanes on the salary matrix; William Fabel moved to amend the motion to include language in the contract stipulating that the credits cannot be used for attainment on the salary schedule. William T. C. Wood seconded the motion to amend the motion. The motion to amend the motion carried.

CONSIDERATION OF SUMMER TRAFFIC ED PROGRAM: Superintendent Wetherbee informed the Board that Mr. Johnson will receive his certification in June, and plans to begin the summer driver's education program no later than July 5. William Fabel moved to approve the summer traffic education program for FY22, and John Russ Hamilton seconded the motion. The motion carried. Further discussion included student enrollment for the program; Superintendent Wetherbee stated that older students will have priority, and that the class may be full due to not having a program last summer.

REVIEW AND/OR APPROVAL OF CURRENT BILLS AND EXPENDITURE PROPOSALS:

Expenditures

William T. C. Wood moved to approve the May warrant list as presented, including warrants #109448 through #109494 totaling 83,676.25, and John Russ Hamilton seconded the motion. The motion carried.

Expenditure Proposals: Boardworks Education-Teacher Resource: Superintendent Wetherbee presented a quote and demonstration for Boardworks, an online resource for K-12 curriculum for all subjects; the program costs \$20,690; all teachers will be able to utilize it, and the quote includes professional development; it is an easy resource to integrate into existing curriculum and lesson plans. Discussion included, but was not limited to, the following: the District has smart and innovative teachers, and this could be an expensive video game; purchasing supplemental materials for all grade levels and different curriculums is very expensive, and this is more cost effective; it seems like a

good resource, but the timing is wrong after asking for a mill levy; the software has a lot of value for students and teachers; the software can be purchased with ESSER II money, because it is another tool that addresses learning loss, and would be useful for remote learning; it is not worth the money if only one or two teachers utilize it; teachers can be more hands-on, and can find other free resources; it is another tool for substitute teachers; some staff members have previewed it and like what it offers, but if there is more buy-in from staff, it seems like a smarter investment. William Fabel moved to approve the purchase of the Boardworks K-12 Education Suite on Superintendent Wetherbee's recommendation. William T. C. Wood seconded the motion. The motion carried, with John Russ Hamilton, Therese Sutton, and William T. C. Wood opposed.

PRINCIPAL'S REPORT:

Principal Stout reported on the following:

- April attendance K-6=94% 7-8=95%, 9-12-92% K-12=94%;
- April students of the month;
- Madison County Track Meet was May 3rd, Sheridan hosted the meet, and it was held in Dillon; Sheridan's 5th/6th grade boys placed first and the girls paced 2nd;
- The spring concert will be filmed next week and put on the school YouTube channel; next year, concerts will all be in person;
- Spring MAPs testing is happening this week, and he hopes to be finished next week;
- Upcoming dates: See enclosed

SUPERINTENDENT'S REPORT:

- Enrollment is currently 64 students in high school, 24 students in middle school, and 98 students in K-6, for a total of 186 students;
- Discipline: Middle school students have had some after-school detentions, and some high school students have received after-school or lunch detentions, and four students have been suspended;
- Summer projects: the sprinklers are being prepped to be turned on, and he is working on getting the front steps of the s will be repaired/replaced high school repaired or replaced; the elementary gym floor will be refinished as soon as school is over, and the gym will be closed during June; the high school gym floor will be refinished at the same time, but will only be closed for one week due to the different type of finish;
- The 8th grade boys' track team placed at the Deer Lodge meet last Saturday;
- High School Track is winding down, and he anticipates about 8 kids will advance to the divisional meet, and 3 or 4 qualifying for the state meet;
- The seniors will graduate on May 30, on the football field, weather permitting; there will be no restrictions on spectators;
- 8th grade graduation will be held the last day of school;
- He reminded everyone that we can't lose focus during the last few weeks, because there is testing, portfolios, and finals still to come.

Exiting board members Rhonda Boyd, William Fabel, John Russ Hamilton, and Klint Todd were recognized for their service to the Board, and presented with a certificate and gift.
